## Other applications

ATA Carnets are accepted for Customs transit.

This information falls under the International Convention on the Simplification and Harmonization of Customs procedures (Kyoto Convention), Annex E – Transit.

ATA carnets **are** accepted via the postal environment provided the carnet accompanies the parcel and the goods qualify for temporary importation under a specific Customs convention that Australia is a party to.

## Languages in which Carnets should be completed

Australian Border Force (ABF) require that any carnet presented for clearance of goods on a temporary basis must be written in English. The wording must be legible.

## Replacement carnet

Yes, in accordance with Article 14, Annex A of the Istanbul Convention

Requests for replacement carnets must be made for approval. Form B257 must be completed and emailed to VCCI for approval BEFORE the replacement carnet is issued and BEFORE the carnet expires.

### **Customs offices**

Not all ports and airports within Australia are permanently staffed by ABF officers.

Some ATA carnet goods may require physical examination by Cargo Examination officers, or the Department of Agriculture, Fisheries and Forestry (DAFF), before the carnet can be endorsed and the goods released from customs control.

Goods hand carried by passengers will require the carnet to be presented for endorsement, and the goods may be examined by ABF officers on importation at the airport of first arrival.

Goods imported by Sea and Air cargo require carnet presentation during business hours to the relevant ABF Clearance office (discharge port) for endorsement. If goods require examination an appointment will be arranged.

## **Special observations**

- GST applies to goods imported into Australia in addition to any duty payable. Therefore, national
  guaranteeing organisations and their issuing offices need to include GST when establishing the amount of
  security required from applicants for ATA Carnets intending to be used in Australia. The security should
  cover Customs duties (CIF value of the goods) plus 10 percent GST.
- Evidence of Identity Still applies. Please see current information: Evidence of Identity for documentary declarations
