### Languages in which Carnets should be completed

German. The Customs may require a translation if the Carnet is completed in any other language, unless the particulars given can be understood. In practice, no difficulty arises in respect of the languages normally used in the EU for international trade.

## Replacement carnet

1. Yes, in accordance with Yes, according to Article 251 Union Customs Code (UCC) (<http://data.europa.eu/eli/reg/2013/952#:~:text=Article%20251%2ctemporary%20admission%20procedure>).
2. When the original carnet expires and a replacement carnet needs to be processed, if the goods are located in Austria, this procedure can take place in Austria even if the initial importation was made in another EU member state.
3. Additional observations (if any):  
In any case, the replacement carnet must be presented to the competent customs office before the first carnet expires. The customs office may also demand the presentation of the goods.

## Regularization fee requested by Customs

Austrian Customs authorities charge a regularization fee of 10 % of the import duties and taxes that should have been claimed in case of proof of indirect re-exportation was submitted. However, this regularization fee is limited to approx. € 113,00 and depends on the administration fee claimed by the Austrian Ministry of Finance which is revised on a regular basis.
