2. When the original carnet expires and a replacement carnet needs to be processed, if the goods are located in Denmark, this procedure can take place in Denmark even if the initial importation was made in another EU member state.

All District Customs offices are authorized to accept ATA Carnets.

From 8 a.m. to 4.30 p.m. In ports and smaller places of call: From 7 a.m. to 4.30 p.m.

Special observations

The Faroe Islands are NOT considered as part of the Danish customs territory.

Consequently, ATA Carnets are necessary for temporary admission operations in the Faroe Islands for enterprises coming from other countries of the European Union.

The Danish Chamber of Commerce acts as the national guaranteeing organization for the Faroe Islands.

In addition, ATA Carnets **are not** accepted in **Greenland**.
