Languages in which Carnets should be completed

Dutch, English, French or German. The Customs may require a translation when the Carnets are completed in any other language.

Replacement carnet

1. Yes, in accordance with Article 251 Union Customs Code (UCC) (<http://data.europa.eu/eli/reg/2013/952#:~:text=Article%20251%2ctemporary%20admission%20procedure>).
2. When the original carnet expires and a replacement carnet needs to be processed, if the goods are located in the Netherlands, this procedure can take place in the Netherlands even if the initial importation was made in another EU member state.
3. Additional observations (if any):
It must be noted that the approval of Customs to go ahead with the use of a replacement is on a case by case judgement. This is subject to having valid reasons to have to stay longer.

Regularization fee requested by Customs

A regularization fee is charged by Dutch Customs, but only when the following scenario applies:

A claim is filed, the period for the production of proof expires, Customs charge duty/taxes, carnet holder wakes up and produces proof and this is accepted (refund duty/taxes).

Thus only in case of a positive reaction (and refund) to proof submitted after payment of duty and taxes.

The amount is at present 10% of the sum of the duty and taxes with a maximum of € 140

Customs offices

All Customs offices on frontiers and at seaports and international airports.

Customs offices are open when the above Customs offices are open for passenger traffic.
