### Languages in which Carnets should be completed

Slovak, Czech, English. The Customs may require a translation when the ATA Carnets are completed in any other language.

## Replacement carnet

1. Yes, in accordance with Article 251 Union Customs Code (UCC) (<http://data.europa.eu/eli/reg/2013/952#:~:text=Article%20251%2ctemporary%20admission%20procedure>).
2. When the original carnet expires and a replacement carnet needs to be processed, if the goods are located in Slovakia, this procedure can take place in Slovakia even if the initial importation was made in another EU member state.
3. Additional observations:  
The replacement ATA Carnet is issued for a period of up to one year and must be presented to the competent customs office during the validity of the original ATA Carnet. The replacement carnet can only be issued once. **Further subsequent replacement carnets shall NOT be accepted.**
4. Carnet holders are advised to contact the customs authorities well in advance of the expiry of the original carnets in order to avoid time stress. This is due to the fact that the customs authorities must not only accept and register a replacement carnet, but also inform the relevant customs office of entry of its acceptance, so that the latter may not initiate proceedings to assess the customs debt and other payments.

## Customs offices

All Customs offices are authorized to accept ATA Carnets during normal opening hours.

## Special observations

Since May 1, 2004 the Slovak Republic is a European Union Member State and a member of the Monetary Union since January 1, 2009 and applies the single EC Customs Tariff and Regulations (EU Customs Code).

Internal transit in Slovakia (EU): the Slovak Customs authorities require for the entry of all the kind of goods covered by ATA Carnets in the Slovak territory the use of blue transit vouchers for internal transit from the Border Customs offices on the EU external border of the Slovak territory (the only EU external border is the Ukraine – Slovakia border) to the Inland Customs offices, which are competent to release the goods on the carnet for temporary importation (white entry voucher) in Slovakia (EU).
