The regularization fee is charged by Swiss customs in case of presentation of an alternative proof (proof of re-importation, Certificate of location, issued within validity time of ATA Carnet).

The regularization fee is calculated by 5 % on the amount of duties and taxes due in case of missing proof, minimum CHF 20.00 / maximum CHF 100.00.
