








UBICAZIONE DELLO STAND STAND LOCATION



STAND BUILD-UP AND DISMANTLING SCHEDULE

SET-UP STAGE

- Halls 3-5-7-8-9-10-11-12 and outdoor Area A, B, C, D, Avenue E, H and G:
- from 7:00am to 8:30pm, from 14 to 25 September 2021;
- from 7:00am to 6:00pm, on 26 September 2021.
- Halls 2-4-6 and Services Centres Castelvecchio (between Hall 2 and 3), delle Erbe (between Hall 4 and 5) and Arena (between Hall 6 and 7):
- from 7:00am to 8:30pm, from 16 to 25 September 2021;
- from 7:00am to 6:00pm, on 26 September 2021.

Stand installation and decoration must be completed by 6:00pm on 26/09/2021.

On 27 September 2021 the access to the pavilions and areas mentioned above will not be permitted owing to compulsory sanitation of all spaces in the Exhibition Centre.

On 28 September 2021 from 5:00 am and until 5:00 pm access to the pavilions and area mentioned above will be permitted to exhibitors only to see their booths and/or eventually to accommodate their samples. On 28 September 2021 therefore, stand installation, construction and/or material handling operations will not be permitted and access will be denied to all stand contractor/fitters companies.

DISMANTLING STAGE

- Halls 11 and 12:
- from 7:00am to 8:30pm, from 3 to 5 October 2021;
- from 7:00am to 4:00pm, on 6 October 2021.

Stand dismantling in Hall no. 11 and 12 must be completed by and no later than 4:00pm on 6 October 2021.

- Halls 2-3-4-5-6-7-8-9-10 and outdoor Area A-B-C-D, Avenue E, G and H:
- from 7:00am to 8:30pm, from 3 to 6 October 2021;
- from 7:00am to 4:00pm, on 7 October 2021.

Stand dismantling must be completed by and no later than 4:00pm on 7 October 2021.

PERSONAL PROTECTIVE EQUIPMENT DURING STAND BUILD-UP AND DISMANTLING

In accordance with consolidated Health and Safety at Work Regulations (ref.: Legislative Decree D.Lgs. 81/2008) and Veronafiere Technical Regulations, throughout the installation and dismantling periods all exhibitors, stand contractor companies and their employees inside the Exhibition Centre must wear **appropriate P.P.E. Personal Protective Equipment** to ensure safe working conditions: safety shoes, high-visibility jackets, etc... Workers who do not have appropriate PPE will not be allowed to continue stand installation and fitting work until the safety measures required by law have been complied with.

All personnel must also be provided with the **Barcode pass** (mandatory for persons and vehicles to access the fairgrounds, and not transferable) which can be printed directly from the Access Control Portal only when the stand project documentation is approved by Veronafiere appropriate offices, as well as with an **ID working badge** issued and supplied by their own companies. This working pass should have a passport photo of the person wearing the badge, name and surname of the person, Company name, address and phone number.
